In the past in 2006, Shri Brahm Singh Tanwar, Ex-MLA inaugurated new Out Patient Door Block and added Auto- Perimeter to the present Ophthalmic department in presence of our valued donors Mrs. Nirmal Mittal and Mr.C.D.Mittal (M/S Nirmal Manufacturing and Marketing Company).

Mrs.& Mr.Mittal always came forward to donate generously for a good cause to help the poor from time to time.They helped in establishing Dental Department and furnishing of the teaching blocks.

Apart from the above many of our valued donors contributed towards installation of YAG laser, Phaco-Emulsification and Auto-Perimetry in Ophthalmic department.

Location

The Institute is situated in such a peaceful and calm atmosphere surrounded by holy temples and god fearing persons in the rural area of Delhi. The institute is having its training centre, Centralized office and Rural Hospital at Street No.5, Pahari Chatterpur, N. Delhi - 110074 and is very famous in the area as Eye Hospital.

Status

The institute is a registered society registered under societies registration Act XXI of 1860 bearing No. S-25306/94. The institute is also **registered U/S 12A & exempted U/S 80G of Income Tax Act** for carrying out various Charitable activities in the rural area of Delhi.

Objectives

The main objectives for which the institute had been leading since its inception are

- To organize, conduct short and long term training courses and programmes in para-medical and related fields.
- To raise education standards in the country in the para medical and related fields.
- To conduct research activities, award, scholarship, prizes, award certificates or diploma.
- To provide compassionate and high quality eye care, medical facilities in Pathological laboratory, Dental and Medical at an affordable cost to all sectors of the society, rural and urban through its **Rural Hospital**, viz.
 - (a) **Daily Subsidized OPD** Consultation by the physician and Gynae. Consultants.
 - (b) **Daily Subsidized Dental care** Check-Up.
 - (c) **Daily Subsidized Eye Specialist clinic** .
 - (d) **Eye Operations** -Free Cataract and other eye surgeries.
 - (e) **Subsidized** Intra-Ocular Lens Implantation including Phaco-Emulsification.

- (f) **Subsidized** Pathological & various laboratory Investigations.
- (g) **Subsidized** Ultrasonography, X-Ray and ECG facilities.
- (h) **Subsidized** lens & Frame making.
- (i) **Subsidized** YAG Laser facilities.
- (j) **Subsidized** Perimetry facilities.
- (k) **Synoptophore and Biometry** facilities.
- (l) **Subsidized** physiotherapy exercises and consultation.
- (m) To keep the fee structure of all the courses conducted by the institute as nominal, to help each sector of the society.
- (n) To provide financial relief to poor and needy students such as fee concessions/ exemptions or concessions in Hostel Charges, etc.

The ECG certificate course is permitted for the students of IPMT only, those are admitted in either Diploma courses in Physiotherapy, X-Ray Technology, Medical Laboratory technology, Dental Assistant and Ophthalmic Assistant. The ECG certificate course is not permitted for fresh candidate's separately.

Duration of Courses

The institute is conducting **Diploma Courses with different durations as mentioned detailed above** with limitation of seats to provide best training to the students which are the integral part of the main objective of the Institute.

Recognition

*The Institute is **recognized by State Govt . of Nagaland, vide their letter No. MED/MISC - 4 / 95 dated 31/10/1995 and was renewed on dated 13th**

December 2005. The addition of courses are **Recognised by the Department of Health & Family Welfare, Government of Nagaland vide their order letter dated 22/06/2009.** The diploma holders are eligible for registration of their names in Employment Exchanges according to the answer to **USQ. No. 3675 dated 22/12/98, in Lok Sabha by Minister of Labour, Government of India** for the purpose of employment in various Government / Non-Governmental organizations.

Two candidates are taught **free** in all the courses **forwarded through Ministry of Health and Family Welfare/Directorate of Medical Services, Government of Nagaland, Kohima.** No Tuition Fees will be charged from them. But, they have to pay the Hostel and Mess Charges of the institute. **(For FREE seat forwarding / recommendation letter will be required in original from the above said department at the time of admission duly forwarded through the Directorate of Health Services, Govt. of Nagaland, Kohima).**

The Institute was **recognized by State Government of Jammu & Kashmir, vide Govt. order No. 233 H&ME of 2003 dated 20/03/2003 and Govt. order No. 531-HME of 2007 dated 08/08/2007.** **Five candidates** will be taught **free** in all the courses **forwarded through Department of Health & Medical Education, Government of Jammu & Kashmir, Jammu/Srinagar.** No Tuition Fees will be charged from them. But, they have to pay the Hostel and Mess Charges of the institute. **(For FREE seat forwarding / recommendation letter will be required in original from the above said department at the time of admission).**

Diploma in Dental Assistant is not recognized by Dental Council of India in any manner nor its registration is carried out at the aforesaid council. This course is for the assistance of the doctors only.

Diploma in ANM (Assistant Nursing & Midwifery) is not recognized by Nursing Council of India in any manner nor its registration is carried out at the aforesaid council. This course is for the assistance of the doctors only especially in the rural areas.

Diploma in Multipurpose Health Worker is not recognized by Any Council in any manner nor its registration is carried out at any council. This course is for the assistance of the doctors only especially in the rural areas.

Continuing Education

The institute is authorised study centre of many deemed universities (Approved by Directorate of Distance Education, IGNOU, New Delhi). It is an opportunity for the candidates that after qualifying their diploma, they can take admission in their respective degree courses into the second year through lateral entry to continue their studies and complete graduation under distance education mode as per university norms and eligibility. The students have to attend to their classes at the institute in the weekends and holidays. This helps to continue their studies for the working personels.

Nomination/Permission

In-service candidates of **Deen Dayal Upadhyay Hospital**, Hari Nagar, New Delhi were permitted for higher studies in Diploma in X-Ray Technology in 1995-96, 1995-97 & candidate from **ESI Hospital**, Basai Darapur, New Delhi were permitted for higher studies in Diploma in X-Ray Technology in 1996-97. There are number of candidates nominated by Department of Health & Medical Education, Government of Jammu & Kashmir for their studies in Medical Laboratory Technology and X-Ray Technology in session 2002-2004 and selected

candidates were provided internship training at Associated Hospital at Jammu & Kashmir successfully.

Vide order dated 22/06/2009 from Department of Health and Family Welfare, Government of Nagaland 15 students are nominated for education in various courses (Medical Laboratory Technology, X-Ray Technology, Ophthalmic Assistant, Dental Assistant, Physiotherapy Assistant, Operation Theatre Technology, Multipurpose Health Worker, Assistant Nursing and Midwifery, ECG Technology) in the session 2009-10.

Training

During the training the Institute provides complete theoretical and practical training at the Institute itself while a field practical training for six months is provided at various potential hospitals of Delhi after completion of his / her second academic year to the **selected students** only without any charges depending upon the hospital. In case if any charges are to be taken by the hospital for the training, it is to be deposited directly at the hospital or through the Institute separately.

Today, the institute developed a vast network by attaching itself to various blood banks, hospitals of Government/ Non-Governmental organizations in and around Delhi viz. **Central Hospital**, Northern Railway, New Delhi, **Northern Railway Divisional Hospital**, New Delhi, **R.B.T.B.Hospital (MCD)**, Kingsway Camp, New Delhi, **Mata Chanan Devi Hospital**, Janak Puri, **Charak Palika Hospital**, NDMC, Delhi and **Various other potential Hospitals** of Delhi/New Delhi etc. The field training is only provided to the selected candidates depending on their performance in the second/ final examinations. The students can arrange their own field practical training for six months in any of the reputed Hospital/ Nursing Home/ Laboratory with prior written permission from the office.

It is having various Original & Fibre Models, Charts of various human body organs and systems.

Department of Radiodiagnosis

It is fully equipped with Ultrasonography, Diagnostic X-ray with Fluoroscopy Unit having latest Digital Control and Dental X-Ray unit along with fully equipped Dark Room.

Department of Pathology

It is fully equipped with Research Microscopes for Clinical Pathology, Hematology for testing of various blood related disorders.

Department of Biochemistry

Fully equipped with Semi- Auto Analyzers, Research Microscopes and Calorimeters etc. for biochemical tests.

Department of Histotechnology

Fully equipped with Microtomes, Wax Baths, Research Microscopes etc. for preparation of various tissue fixation, section cutting etc.

Department of Microbiology fully equipped.

Department of Ophthalmology

Fully equipped with YAG Laser, Perimeter, Appascan-A (Biometry), Synoptophore, Retinoscope, Slit Lamps, Keratometers, lensometer, Ophthalmoscope, Tonometer, Inami head Operating Microscopes, Phaco-Emulsifier added for Microsurgery purposes. Lens grinding, Fixing, Cutting and Framing including Eye Testing facilities.

Dental Department

It is equipped with latest Dental Units and instruments for the best treatment of all dental problems including artificial denture (Fixed and removal), Tooth filling, Minor surgical procedures, Removal of orthodontic appliance, Scaling (Ultrasonic), Root canal treatment, Dental X-Rays etc.

Department of Physiotherapy

It is fully equipped with short Wave diathermy, Wax Bath, Hot pack, Shoulder Wheel, Ultrasound, TENS, Cervical and Lumbar, Traction Unit, Ankle Exerciser, Parallel Walking Bars, Peg Boards and various other exercises machines.

Department of Computers

It equipped with latest Pentium IV computers for teaching its usage in related programmes with all associated CD's and softwares. It is equipped with CD's related to Ophthalmic Surgeries, X-Ray Procedures and Medical Laboratory blood slides and software of laboratory test reporting.

Library

It is having a large collection of reference books on different subjects relating to the course syllabus and other general books / magazines to update the knowledge of the students . The books are issued to the students for their home reading for a period of fortnight.

Audio-Visual Centre

It is having various Medical Video Cassettes from " Medical Video Television Network", for teaching purposes and to demonstrate the live recording on various procedures of the course syllabus, Models on various subjects, Charts and Slides. It is equipped with Epidiascope , Slide Projector and Overhead Projector for demonstration of figures of various human body organs and systems, text on larger screens for better understanding of the

students.

ECG Centre

Fully equipped with latest modern machines.

Physics Laboratory

Equipped with instruments to explain various scientific applications and procedures.

Operation Theatre

An Operation Theatre fully equipped with Operating Microscopes, Cryo Machine and Phaco-Emulsifier for Microsurgery in which the Intra - Ocular lens Implantation and other eye surgeries are performed.

Wards

Comprising of latest fitted beds for indoor patients having all facilities. The charges for the same are as per the charity done by the society.

Latest furnished Lecture Halls with individual sitting facilities.

Furnished separate Boys & Girls Hostels

It is adjacent to the Institute. The rooms are allotted on twin share basis. The hostel is having 24 hours water supply with its own boring facility.

Attachments

In eye camps the patients are screened at the spot and the patients requiring surgery are brought and treated at the institute. 1. The duration for all the Diploma Courses is Two academic Years excluding Six Months field practical training at potential hospitals of Delhi/ New Delhi to be provided to selected candidates only as per rules and regulations of the related hospital.
2. Each academic year starts from July and ends in May next year.
3. 75% of attendance is compulsory to appear in the final examination and long leaves are only permitted if prior permission is taken from the office incharge / principal in written only.
4. There will be regular theoretical and Practical training at the training centre of IPMT starting from 9.00 AM/10.00AM daily except Sunday and gazetted holidays.
5. Hostel Accommodation will be provided in the premises; [on first come first serve basis] provided prior requisition is made alongwith at the time of admission. The boys hostel & girls hostel is having all facilities for indoor games also.
 - a] **Separate Boys and Girls hostel is provided.**
 - b] The operation of kitchen or mess entirely depends on the student's interest which will be approved by the principal/ office incharge.
 - c] NO student will be permitted to go out or stay out of the hostel after **8PM** without prior written permission of the hostel warden.

- iii] The Menu fixed by the hostel warden will be final and no other demand or the choice of menu by the student will be permitted.

6. **Eligibility**

Minimum qualification to seek admission in any of the above mentioned courses will be 10+2 or equivalent from a government recognized Institution / Board. Matric or equivalent [with approval of the Registrar / Management of the institute] depending upon the course.

7. **Reservation**

There is provision for SC/ST or backward class. Kindly apply alongwith attested photocopy of documents from the appropriate authorities.

For the Candidates Nominated By Government of Nagaland Only

Two Candidates in each diploma course approved by Govt. of Nagaland will be educated FREE (Exemption of 100% Tuition fees)- Apply with forwarding / recommendation letter from the Department of Health and Family Welfare, Government of Nagaland.

For the Candidates Nominated By Government of Jammu & Kashmir only

Five Candidates in each diploma course approved by Govt. of J&K will be educated FREE (Exemption of 100% Tuition fees)- Apply with forwarding / recommendation letter from the Department of Health and Medical Education, Government of Jammu & Kashmir, Jammu/ Srinagar.

As per the policies of the institution the admission is provided to limited number of students to provide them good quality of education in their respective fields for which the admission is only provided to the selected candidate only after approval by the selection committee after conducting face to face viva/interview with the candidate. The rights of admission confirmation are reserved with the Principal/Registrar/Management of the Institute.

8. **Medium**

Medium of instructions used will be English / Hindi [80% English and 20% Hindi- communicative].The final examination question papers will be in English script only.

e] There will be four theoretical and One Practical examination for each course except Ophthalmic Assistant and Dental Assistant having Three papers each year. In addition, there will be Viva Voice -I [Practical] and Viva Voice - II [Oral].

f] Re-checking of any examination papers can be done within 15 days from the date of declaration of results only after submitting an application alongwith a rechecking fees of Rs.100/- per paper.

g] The decision or the result prepared and declared by the Registrar / examining body of the institute will be final and binding on the student.

h] The original diploma and Marksheet will be issued to the successful

candidates on completion of his/her both year examinations only. In case if a candidate wish to undergo training through the institute than the Marksheet and diploma will be issued after completion of the training period from the concerned hospital/ Nursing Home and producing the related documents to the office.

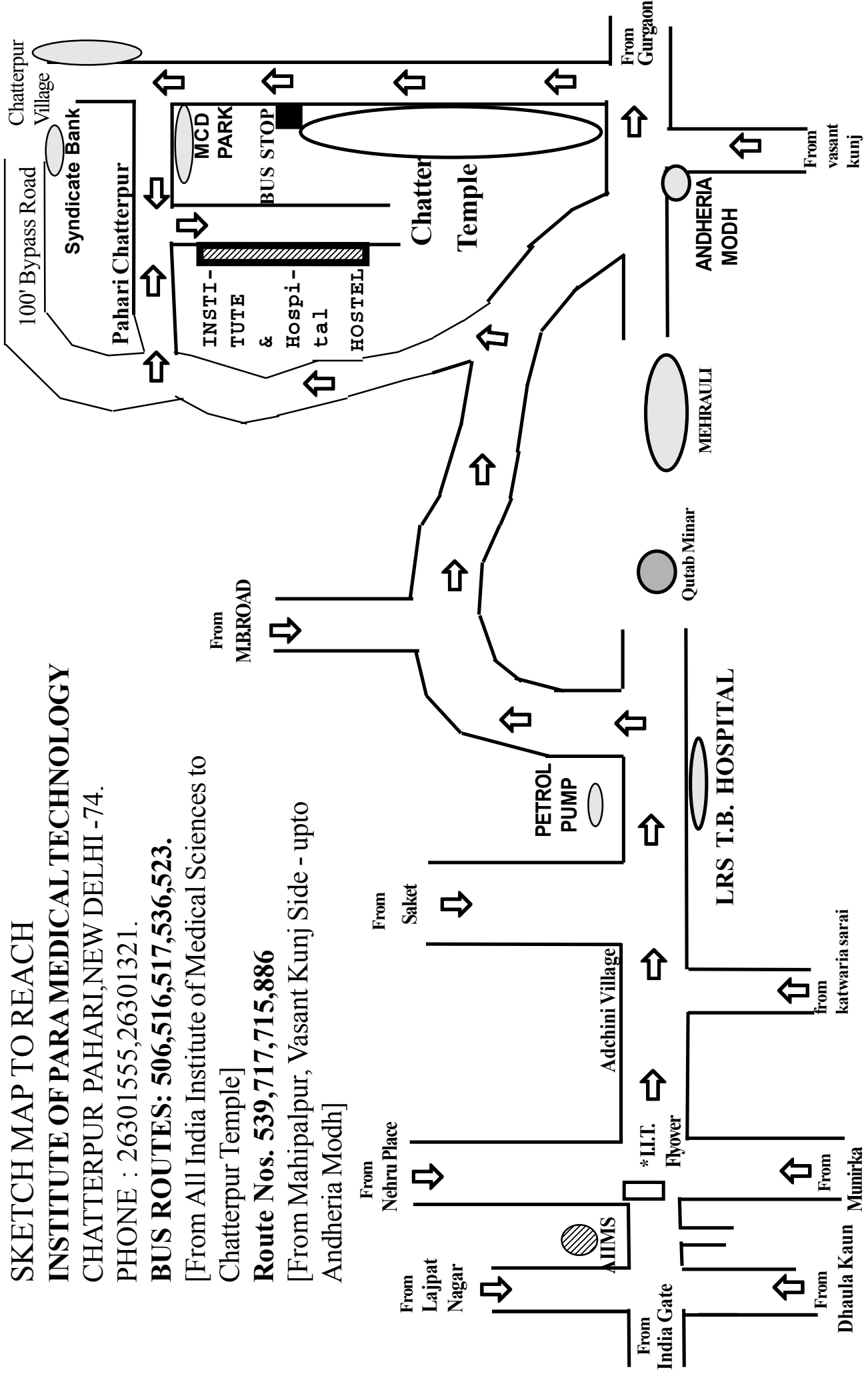
